Resolva Moss Killer is a ready to use formulation that effectively kills moss and algae on natural and permeable surfaces overlying soil (e.g. block paving, gravel and decking).

INSTRUCTIONS FOR USE

WHEN TO USE - Resolva Moss Killer can be used any time of the year • However at temperatures below 15°C the effects may be lessened • Rainfall within less than 12 hours after the treatment may impair the effect of the product • Do not spray in windy weather.

Crops/situations	Maximum individual dose	Maximum number of treatments
Unwanted vegetation	1L treats 10sq.m	8 per year
Ornamental garden plants	1L treats 10sq.m	4 per year

WHERE TO USE - For use on unwanted vegetation • Take extreme caution; kills all green plant growth including grass • Do not apply to cultivated plants or lawns unless you want to kill them • Controls mosses and algae on natural surfaces not intended to bear vegetation and permeable surfaces overlying soil (e.g. block paving, gravel and decking) • This product is suitable for use on gravel or other permeable surfaces where no vegetation is wanted, including around the base of walls and sheds, and on any waste ground which is not intended for growing • Do not use on impermeable surfaces such as concrete, tarmac or paved areas, where the solution might run off onto adjacent land, or into drains or gutters • Avoid drift to vegetables and other plants by pointing the spray away from them.

HOW TO USE - Always read the label fully before use • **SHAKE WELL BEFORE USE** • Prepare the sprayer for use: 1. Remove sprayer trigger and unwrap hose completely 2. Remove white security seal 3. Lift bottle cap lid 4. Fully insert plug attached to the hose end into the bottle neck 5. Turn sprayer nozzle to required sprayer pattern (half turn fine spray, full turn coarse jet) 6. Squeeze trigger repeatedly to commence spraying • Spray weed leaves lightly until fully wetted but avoid run off • Turn nozzle to "X" position after use and before storage • For long-term storage replace the trigger back into slot • Do not walk into treated areas until the spray has dried to avoid transfer to lawns and other vegetation • Do not direct spray or allow spray to drift onto cultivated plants, as Resolva Moss Killer destroys all green plant parts • Mosses and algae on natural paths will usually be controlled by a single application but repeat application may be applied at 3-4 week intervals if incomplete control is achieved or following regrowth • Areas treated can be re-entered immediately after drying of the spray • Children and pets need not be excluded from treated area once dry • Treats up to 30sq.m.

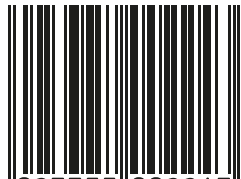
